

MEMBER AGREEMENT

Between

QUANTUM HEALING WATERFRONT LOUNGE

And

THE MEMBER

By joining the Quantum Healing Waterfront Lounge, a private unincorporated wellness association, (The “Association” hereafter), and/or any website or social media group started by, created by, maintained, or organized by the Association, the “Member” agrees to the terms and conditions of this Member Agreement contract, as follows:

1. I understand and agree the only public offering the Association has made to me has been a membership;
2. I understand and agree the products and services offered via the Association will be limited to those member-only products and services offered to this specific level of membership;
3. I understand and agree the scope of this agreement includes, yet is not limited to, all assets utilized for operating the membership, such as websites, social media groups, video conferences/meetings, online and in-person events, gatherings, premises, documents, and more, and that all assets are strictly for membership use only, and are to be held to a honourable level of confidentiality and not to be shared with those outside the membership, without the express authorization of the administrators of the Association;
4. I understand, agree and accept that the Association is comprised of a spiritually driven meeting of the minds of those of mankind, who seek to serve the world responsibly in accordance with the principles of the Association;
5. I understand, agree and accept that the Association operates entirely in the private domain and shall be governed by contract law, without the public, or any City/Town, State, Province, or Country, such as CANADA, The UNITED STATES OF AMERICA, AUSTRALIA, UNITED KINGDOM, or any other legally formed jurisdiction;
6. I understand and agree that the nation of Canada also acknowledges the right of private entities of their unlimited right to contract privately, as acknowledged and reflected in, but not reliant on, international covenants such as, but not limited to, the *International Covenant on Civil and Political Rights*, *The Constitution Act of Canada, 1867-1982*, the *Charter of Rights and Freedoms of Canada*, and the *US Constitution*, and, as a member, agree to protect the rights of the members, including, but not limited to, the absolute freedom of religion, free speech, petition, assembly, and the right to gather together for the lawful purpose, to be free from unreasonable search and seizure, the right to not incriminate ourselves, and the right to be a free;
7. I understand that Association facilitators do not diagnose conditions, nor do they prescribe or perform medical treatment, prescribe substances, nor interfere with the treatment of a licensed medical professional;

8. I understand that energy healing or any service provided by the Association does not take the place of medical care and that it is recommended that I see a licensed physician or licensed healthcare professional for any physiological or psychological ailment I may have;
9. I acknowledge that long-term imbalances in the body sometimes require multiple sessions in order to facilitate the level of relaxation needed by the body to heal itself and that the Association makes no claims of being able to heal any specific conditions;
10. I understand and agree, by signing this Member Agreement, that I am fully aware of the risks and obligations associated with participating in the Association, and I take full responsibility for them;
11. I enter into this agreement of my own free will, without any pressure or coercion, and affirm that any concerns I may have had have been answered and due diligence completed fully to my satisfaction and that signing this agreement creates a binding contract;
12. I affirm I am applying for membership in the Association in my private capacity as one of mankind and I am voluntarily choosing my capacity from that of a public person to that of a private member, and not performing any function of government, acting in any capacity of a public agent of government, legal authority, title or capacity, seeking to enforce any kind of legal act, code, or statute, and that the Association is not engaging in any governmental policy or program;
13. In the case of dependents, I affirm the dependents listed as part of my membership are those of mankind I have legal authority as guardian and/or custodian of, and that I affirm that, in both the public and the private domain, I have the right to contract for and on their behalf;
14. I consent to waiving any right I, my heirs, successors, guardians, and/or legal representatives may have had to file any kind of public legal suit, case or complaint against the Association and/or those who participate within the membership, and fully agree to exhaust the membership protocol of Dispute Resolution Protocol of the Association, outlined in its Constitution;
15. I understand and agree that initiating a legal suit or complaint, unless there has been evidenced a willful and intentional act of harm to myself, or if a breach of contract pursuant to this agreement has been made by the Association, before exhausting the Association's Dispute Resolution protocol, will be considered, by the Association, to be a trespass by way of breach of contract and that the Association has the right to hold me liable to pay compensation in the amount of one hundred thousand (\$100,000 CAD) Canadian Dollars, plus one hundred (\$100 CAD) Canadian Dollars per minute said trespass continues;
16. I understand and agree that the Board of the Association reserves the right to terminate my membership immediately, if my actions, are deemed to be a burden, menacing, irresponsible, destructive, irrational or harassing upon the members, and/or are not in the best interest of the Association, and all access to any property provided through the Association shall cease immediately thereafter; and,

17. I also understand that I can withdraw from this membership agreement and terminate my membership in this Association at any time pursuant to the terms outlined in the Constitution of the Association;
18. I agree to hold any and all knowledge of information and Association dealings in confidence for a period of no less than two (2) years beyond the end of my membership;
19. I understand and agree this level of membership affords me no voting or ownership rights in the Association;
20. Consideration: I understand and agree there is a one-time fee of Ten (\$10 CAD) Canadian Dollars in exchange for lifetime membership and to gain access to the Association's member-only products and services.

These pages consist of the entire agreement for my membership in The Association, and; I agree this contract began on the date of my joining "Quantum Healing Waterfront Lounge", and; I declare that by joining this Association and/or the Association's websites and/or social media group(s), I have carefully read the whole of this document and I understand and agree to be bound by it.
